## Next Steps

1. Appear at a port of entry within seven days. If you do not appear within seven days or are not issued an I-94 for any reason, there are no refunds.
2. At the port of entry, submit your biometrics (if required) and complete an interview.
3. Be prepared to show evidence of your residence, employment and/or travel plans, if asked by the Customs and Border Protection (CBP) Officer.

CBP will issue an electronic Form I-94 to approved travelers. This form will document the traveler's *class of admission* and *admit unit date*. This form must be retained and presented to any government official, law enforcement officer, organization, institution, or employer that requests evidence of lawful admission.

*Note: The persons in the group are not required to travel together.*
